

CAR BORROWER AGREEMENT FORM

This agreement is hereby made between _____ residing in _____ (hereafter referred to as "THE BORROWER") and _____ presently residing in _____ (hereafter referred to as "THE OWNER"). The owner hereby agrees to borrow the vehicle to the borrower with the following details;

TERMS AND CONDITIONS:

- The lessee shall pay the **reservation fee 1000** before renting. Once booking is cancelled, reservation is **NON-REFUNDABLE**.
- The renter understands that the vehicle is for use only within the **City of CEBU, MANDAUE, TALISAY, LAPU- LAPU** and nearby areas. **IN NO EVEN THAT THE VEHICLE SHALL BE BROUGHT OUTSIDE THE ISLAND OF CEBU**. Should be the lessor depart from any **PORT OF CEBU**, The **SECURITY DEPOSIT SHALL BE FORFEITED**, and agrees to pay THE PENALTY OF **5,000 (FIVE THOUSAND PESOS)**.
- The borrower also agrees to clean or wash the vehicle or pay **300 pesos for carwash fee**.
- **Responsibility for loss and damage to the vehicle.** LESSEE is responsible for the FULL VALUE regardless of fault. Whatever brakes in the rented vehicle is LESSEE's responsible to fix/restore back to it's original.
- **Fuel.** Lessee is responsible for returning the vehicle with as much fuel in the tank as when received. If the lessee returned the vehicle with less fuel than we supplied it with, a fuel charge applies. LESSOR determines how many fuel are needed by the refilling of the tank. **AT THE TIME OF RETURN, LESSEE WILL NOT RECEIVE CREDIT FOR ANY FUEL REMAINING IN THE VEHICLE.**
- **LIABILITY.** If the rented vehicle has been lost/car nabbed or in any case that the renter can't return the vehicle then the renter is responsible for the whole amount of the rented vehicle.
